Citizens Group Launches "Yes for Kids" Committee Urges Residents to Support August 6 TCAPS Millage

Traverse City, Mich. – Today, a group of moms, community leaders, parents, grandparents, and citizens launched a "YES" committee in support of the Traverse City Area Public Schools August 6 bond proposal. The Yes for Kids committee believes the August 6 bond proposal includes essential needs that keep kids safe and thriving as they get their education in Traverse City Area Public Schools. The request on the August ballot would not increase the current tax rate; it will maintain the 3.1 mill rate, which is 40 percent below the average of all other Michigan public schools 5.4 mill rate.

"As TCAPS moms, parents, and citizens, we are asking the community to say "YES" in August to keep our kids safe and thriving with the proper equipment and enhanced learning spaces while preserving a historic part of our community," said co-chairs and TCAPS Moms, Sara McCauley and Megan Brown. "These truly are needs – not wants – that will benefit our kids as they grow up and learn in Northern Michigan."

Bond proposal highlights include:

- 1. **Safety and Security Enhancements:** Installation of doors, vestibules, cameras, electronic access and communications' upgrades to ensure the safety of our students from violence or unexpected intruders and the purchase of buses to get our kids to and from school safely.
- 2. Replacements of Old Infrastructure: Replacing roofs, boilers, septic systems, and parking lots.
- 3. Energy Efficiency & Performance Upgrades: Upgrades to lighting, controls and switches.
- 4. **Learning Space Improvements:** Approximately 35,000 square feet of learning space enhancements, including K-12 Music, Science, Technology, Engineering, and Math (STEM).
- 5. **Central Grade School Renovations:** Preservation of the oldest school in the district located in downtown Traverse City with a renovation project.
